# Situation: two visions

- The parish council wants to sell and repurpose the Saint Lucia Church
- As a result, the church is to be deconsecrated by the bishop
- The Stichting Ergoed Lucia Ravenstein presents itself as a buyer and mainly focuses on commercial activities, in addition to social and cultural activities
- The Loterijfonds Ravenstein exclusively opts for a combination of social, cultural and religious activities

- Recognized as Dutch Immaterial Heritage •
- From a social vision legally subservient to the church and the parishioners of the • former Saint Lucia parish
- The Saint Lucia Church was born from the proceeds of the 'Ravensteinsche Lotterie'

A close bond between church and Loterijfonds for 300 years:

- Sposoring priests
- Sponsoring Latin School, French school and Technical school
- Charity (to this day)

### Saint Lucia Church: not just any church


- Monumental heritage church in the center of the Land of Ravenstein. Unique baroque construction and decoration. Almost 300 years old (1735)
- Important link in the counter-reformation policy of Elector Karl III Philipp von Neuburg. A beacon of Catholic faith in a hostile Protestant environment
- Unique and valuable art collection based on gifts and donations and important devotional culture
- The church building and the art objects inextricably linked to it together form a national monument. It's about the combination



There is no "pastoral, devotional or art-historical necessity," the bishop wrote. A historical mistake!

# What does the Loterijfonds <u>not want</u>?

- A Lucia Church that is, in our view, violated, which is no longer a church and has been transformed into an event location. This is expected to result in irreversible damage to the sacred monumental character
- So no (see policy plan SELR):
  - Private dining
  - Movie
  - Theatre/dance
  - Festivities
  - Silent disco
  - Horeca

# What does the Loterijfonds <u>want</u>?

To preserve the Saint Lucia Church as valuable heritage for Ravenstein. A place where religious and cultural activities go together with dignity.

#### So yes

- Walk in (open daily), eucharist, baptism, wedding, burial
- Education (schools), home base for choirs, harmony, liturgical work group, etc.
- Reli- and heritage tourism (in collaboration with TIR, catering, Ambachtelijk Ravenstein, Jan Cunen, Krona, Cultuurwerkgroep, etc.)
- Exhibitions / symposia / information / music and concerts

### Why preserve Saint Lucia as social heritage?

- "To give continuity to the important things in our lives. To give our future a past." (Kerkgebouwen, Rijksdienst voor cultureel erfgoed, 2020)
- Due to its special history and cultural wealth, the Saint Lucia Church is such a place where past, present and future come together.
- It is up to our generation to handle this with care.
